#### Clearlake Capital to Acquire Springs Window Fashions

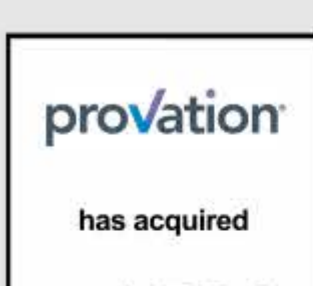

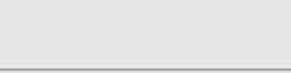

Following the acquisition of PatientPing earlier this year, the new company name reflects the combined company's commitment to deliver whole person care coordination to improve health outcomes.



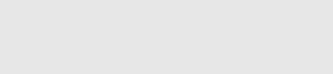
